The Principals of Government Junior Colleges in the State are hereby permitted to open English Medium section along with Telugu Medium in any Group/Section subject to the following conditions

- [1] That there should be no additional financial commitment to Government, either now or in future
- [2] That there should not be any request for additional staff what so ever including engaging of Contract Faculty/Guest Faculty
- [3] The existing staff be only utilized for the academic work/instruction
- [4] No additional fee shall be collected from the students as free education policy is implemented
- [5] That there should be adequate infrastructural facilities to run the new course/section now permitted
- [6] Admissions into such now permitted section's shall be made only after completion admissions in the present existing regular sections/groups. There should be Minimum of strength [i.e] 30 students in science & 40 students in Humanities. The other usual term & conditions prescribed by the Board of Intermediate Education in this regard shall be strictly adhered
- [7] All the Principals of Government Junior Colleges/Government Vocational Junior Colleges are hereby permitted to take any number of students duly relaxing the intake of 88 per section subject to availability of staff, accommodation and no financial burden to Government either now or in future.
